How We Will Calculate Your Balance: We use a method called "average daily balance (excluding new purchases) (including new balance transfers and cash advances)."

Promotional Period for Introductory APR: The Introductory APR for balance transfers will apply to transactions posted to your account during the first nine months following the opening of your account. Any existing balances on Carolinas Telco Federal Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

Loss of Introductory APR: We may end your Introductory APR for balance transfers and apply the prevailing non-introductory APR if you are 60 days late in making a payment.

Effective Date: The information about the costs of the card described in this application is accurate as of: January 26, 2022 This information may have changed after that date. To find out what may have changed, contact the Credit Union.

For California Borrowers, the Visa Platinum Low Rate and Visa Platinum Cash Rewards are secured credit cards. Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings.

Other Fees & Disclosures:

<u>Late Payment Fee:</u> \$20.00 or the amount of the required minimum payment, whichever is less, if you are 5 or more days late in making a payment.

<u>Balance Transfer Fee (Finance Charge):</u> \$10.00 or 3.00% of the amount of each balance transfer, whichever is greater. However, this fee is waived on all transactions posted during the first 60 days of account opening. However, this fee is waived on all transactions posted during the promotional period stated above.

Over-the-Credit Limit Fee: \$25.00 or the amount of the transaction exceeding your approved credit limit, whichever is less.

Returned Payment Fee: \$25.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee: \$5.00.

Rush Fee: \$40.00.

Statement Copy Fee: \$2.00.
