#### What You Need to Know about Overdrafts and Overdraft Fees

An overdraft occurs when you do not have enough money in your account to cover a transaction. Carolinas Telco FCU can cover your overdrafts in two different ways:

- 1. Standard overdraft practices
- 2. We also offer overdraft protection options, which may be less expensive than our standard overdraft practices. To learn more, ask us about these plans.

This notice explains our standard overdraft practices.

### What are the standard overdraft practices that come with my account?

Carolinas Telco FCU may pay overdrafts at our discretion, which means we do not guarantee authorization and payment of a transaction.

We do authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

We do not authorize and pay overdrafts for the following types of transactions unless you ask us to (see below):

- ATM transactions
- Everyday debit card transactions

If Carolinas Telco FCU does not authorize and pay an overdraft, your transaction will be declined.

## What fees will I be charged if Carolinas Telco Federal Credit Union pays my overdraft?
